Part I: Background

1. The FY2010 National Defense Authorization Act (NDAA) amended 10 U.S.C. 1074 to increase the amount of time a Reserve Component (RC) is eligible for TRICARE coverage prior to mobilization from 90 to 180 days. DoDI 7730.54 implements the extension of up to 180 days for Early TRICARE eligibility for RC members activated in support of a contingency operation for more than 30 days are eligible for this program, which also extends to eligible family members.

Part II: Eligibility

2. An RC member who is issued a delayed-effective-date active-duty order, or is covered by such an order, that is for a period of active duty of more than 30 days, in support of a contingency operation, as defined in 10 USC. 101(a)(13)(B), shall be eligible, along with eligible family members, for TRICARE, on either the date of notification of such order, or no more than 180 days prior to the effective date of active duty prescribed in the order, whichever is later.

NOTE ONE: DoD further defines a "delayed-effective-date active-duty order" as either a) individual mobilization orders or b) a unit alert order, with an annex approved by a senior authorized individual for the unit or higher headquarters that contains the identification of all individuals to whom individual mobilization orders will be issued. For ANG members, the latter means matching a notification message that contains a gaining Major Command's (MAJCOM) validated requirement to support a contingency operation as defined in 10 U.S.C. 101(a)(13)(B) with a list of personnel approved by a unit commander or a senior authorized individual in the unit.

NOTE TWO: Early Identification Date (E-ID) eligibility for TRICARE is the later of:

Ninety (90) days prior to the start of activation or the date of notification of the activation start date for delayed-effective-date active-duty orders issued from November 24, 2003, and before October 28, 2009.

One hundred and eighty (180) days prior to the start of activation or the date of notification of the activation start date for delayed-effective-date active-duty orders issued on or after October 28, 2009.

3. Eligibility must also be shown on the Defense Enrollment Eligibility Reporting System (DEERS). Once DEERS has been updated, RC members can verify their eligibility on the Guard and Reserve Web Portal at <https://www.dmdc.osd.mil/Guard-ReservePortal>. In the event a member or family member has an emergency situation warranting immediate attention, he/she will be treated even if the orders are not available or the family member's identification card is not current. Normal procedures to validate eligibility after emergency medical treatment will apply. Nonetheless, members should take great effort to ensure their family members have current identification cards and are enrolled in the DEERS.

Part III: Program Specifics

5. Eligible members will be provided health care by military hospitals and clinics, or by TRICARE-authorized providers, reimbursed through supplemental care rules. RC members will not be enrolled into TRICARE Prime unless, and until, they reach their final duty station. Family members may choose to enroll in TRICARE Prime Remote (TPR) for Active Duty Family Members (TPRADFM) if they reside in a TPR zip code. Family members who reside outside the 50 states will follow the appropriate enrollment procedures for the overseas program.

6. Members who are enrolled in the TRICARE dental program (TDP) and issued delayed-effective-date active-duty orders will be automatically disenrolled and will become eligible for care at dental treatment facilities or through the tri-service remote dental program. Family members enrolled in TDP will continue to be enrolled; however, they will be charged the lower active-duty family member shared premium rate. Those family members not enrolled in TDP are eligible to enroll under this program.

7. The TRICARE Management Activity (TMA) recommends all eligible members and their family members retain any bills for health and dental services provided until the benefit is fully implemented. Upon full implementation, they can submit claims for TRICARE reimbursement if eligible.

Part IV: Medical Coverage/Enrollment

8. TRICARE Reserve Select (TRS) is a premium-based health plan that qualified National Guard and Reserve members may purchase. Monthly premium rate is determined by the type of coverage you purchase: TRS member-only or TRS member-and-family (Visit www.tricare.mil, enter profile, and click on "Costs.")

Disenrollment Due to Change in Status: When an ANG member is called to active-duty service for more than 30 days, the member and their family becomes eligible for non-premium TRICARE plans (e.g., *TRICARE Prime*). At this time, TRS coverage is automatically terminated. When the ANG member's active-duty service ends, the eligibility for non-premium plans ends as well unless the member qualifies for TRICARE transitional health care, otherwise known as Transitional Assistant Management Program (TAMP). **Eligibility information is listed at www.tricare.mil/mybenefit/home/overview/SpecialPrograms/TAMP.**

If an ANG member qualifies for TAMP, that member is eligible for transitional benefits. The member and their eligible family members receive a total of 180 days of TAMP coverage. This 180 day period begins the day after the qualifying active-duty period ends. TAMP eligibles (including the former active-duty member) who were enrolled in Prime immediately prior to their change in status may continue their enrollment in TRICARE Prime with no break in coverage. A reenrollment application must be completed prior to the TAMP expiration period in order to continue with TRICARE Prime. The effective date shall be the date the sponsor separated from active duty as the intent is to ensure that Prime coverage is seamless.

If a service member does not qualify for TAMP coverage, the member must reenroll in TRS within 60 days to continue uninterrupted health care coverage.

Federal employee reservists do not qualify for TRICARE Reserve Select as they are eligible for health care coverage under the Federal Employees Health Benefits (FEHB) Program (unless their position is excluded by law or regulation). Federal employee reservists who are placed in a leave without pay status (LWOP) when called to active duty for more than 30 days can keep their FEHB coverage for up to 18 months. The reservist is responsible for paying the enrollee share of the premium during the first 12 months, and the agency pays the agency's share.

Part V: MILPDS Updates

9. Update of the EID, listed as the “Notify Date” in MILPDS: This updated data flows to DEERS identifying the person as eligible for TRICARE benefits. This will establish the EID at Defense Manpower Data Center (DMDC). “Notify Date” is the date the earliest date on which a member may be notified of a pending deployment. It is also the date the unit commander or senior authorized individual signs the list of personnel to satisfy deployment taskings.

Part VI: Orders Information

10. FOR ORDERS ISSUING OFFICIALS.

As a minimum the following statement will be included on activation orders: “Your Early Identification Date is _____. Based on these orders to Active Federal Service for a period of 31 days or more in support of a contingency operation dated after 28 Oct 04, members and eligible dependents may be eligible for TRICARE benefits. IAW (I), Identification Cards for members of the Uniformed Services, their eligible family members and other eligible personnel, 20 Dec 02, Para 1.19.4, it is the members responsibility to ensure their DEERS record reflects the proper active duty dates if orders are in excess of 30 days. Eligibility period for this benefit begins upon notification or receipt of delayed-effective-date-orders to active duty or up to a hundred and eighty (180) days prior being placed on active duty, whichever is later. Benefits are effective the date you receive notification that you are (or will be) ordered to active duty for a period of 31 days or more support of a contingency operation as defined in provisions of law, 10 U.S.C. 101(a)(13)(b).”

Part VII: Definitions

ACTIVE DUTY: Identifies ANG personnel serving on volunteer or non-volunteer (mobilization) orders. For the purpose of this program, personnel must be serving on active-duty orders for more than 30 days in support of a contingency operation.

EARLY IDENTIFICATION DATE (EID): This is the calendar date a “delayed-effective-date-active duty order” is issued. For ANG members in either a volunteer or mobilization status, this means matching a notification message that contains a gaining Major Command’s (MAJCOM) validated requirement to support a contingency operation as defined in 10 U.S.C. 101(a)(13)(B) with a list of personnel approved by a unit commander or a senior authorized individual in the unit. For the purpose of this program, the EID can never be more than 180 days prior to the active-duty effective date.

DELAYED-EFFECTIVE-DATE ACTIVE-DUTY ORDER: DoD defines this as either a) individual mobilization order or b) a unit alert order with an annex approved by a senior authorized individual for the unit or higher HQ that contains the identification of all individuals to whom individual mobilization orders will be issued in accordance with the unit alert order.

LIM-MOB-UPDATE SCREEN: The update screen in MILPDS provides the area for updating information for personnel who are serving on active duty. While the screen implies it is used only for mobilizations, volunteer data must be updated as well.
